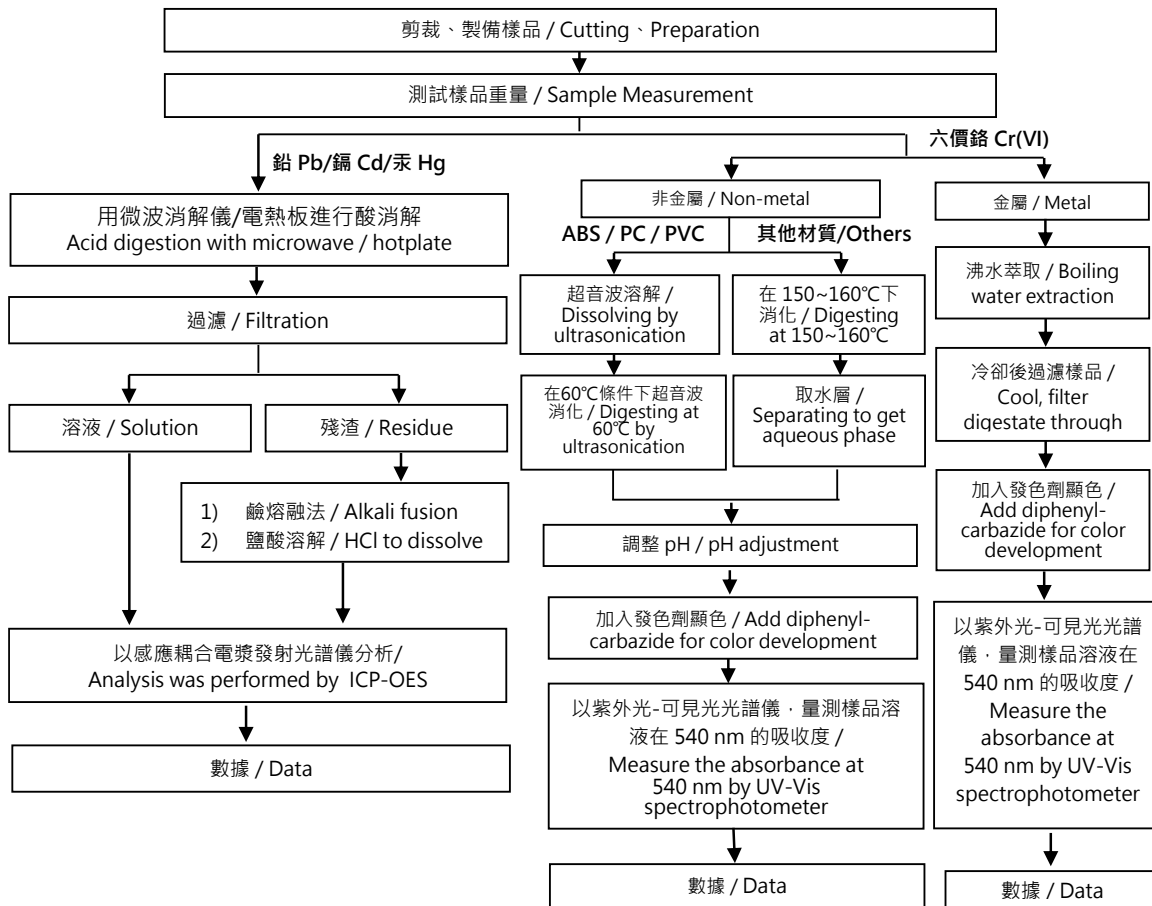

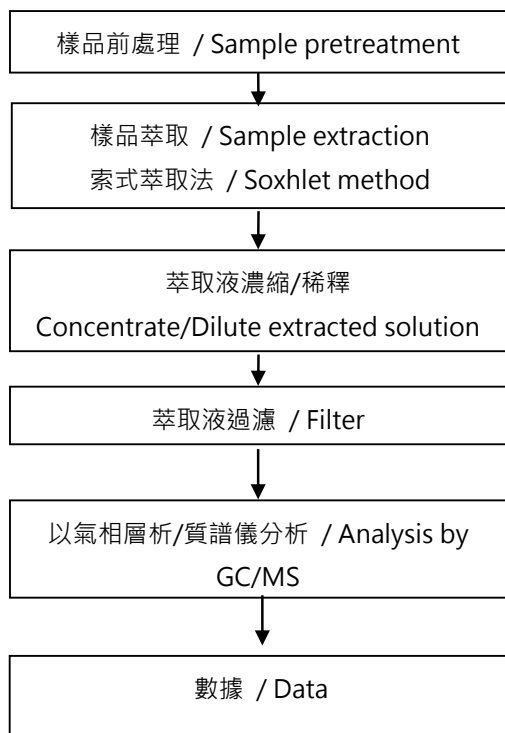

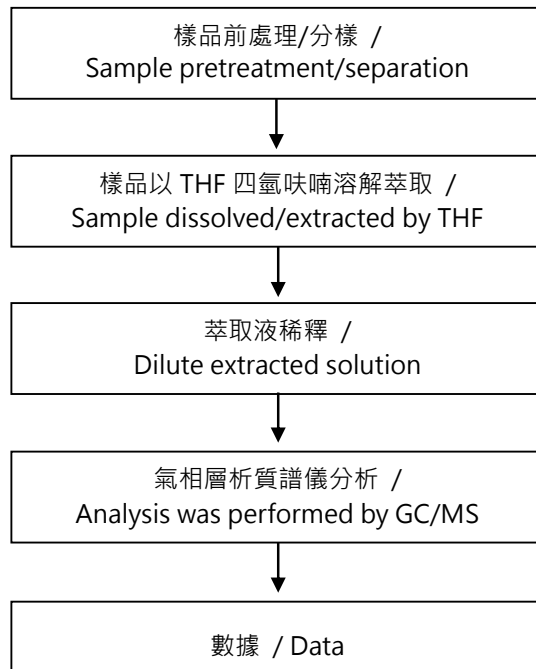
多溴聯苯/多溴聯苯醌 分析流程圖 / PBB/PBDE analytical FLOW CHART

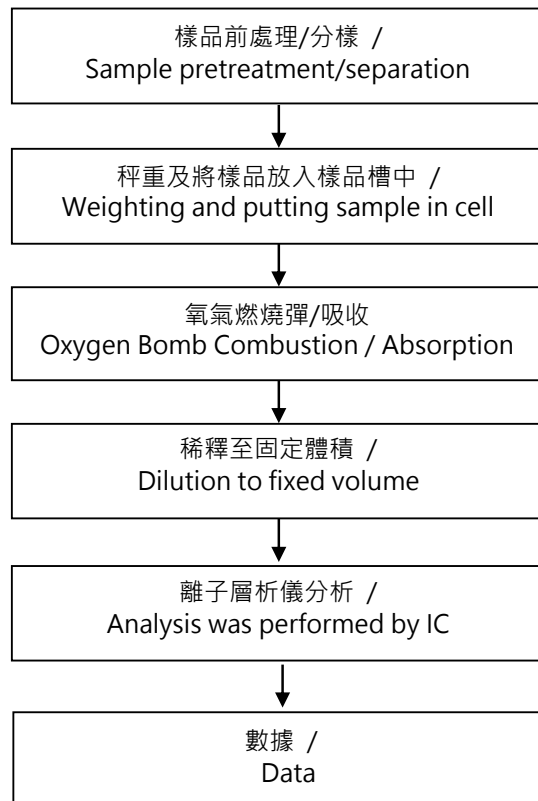

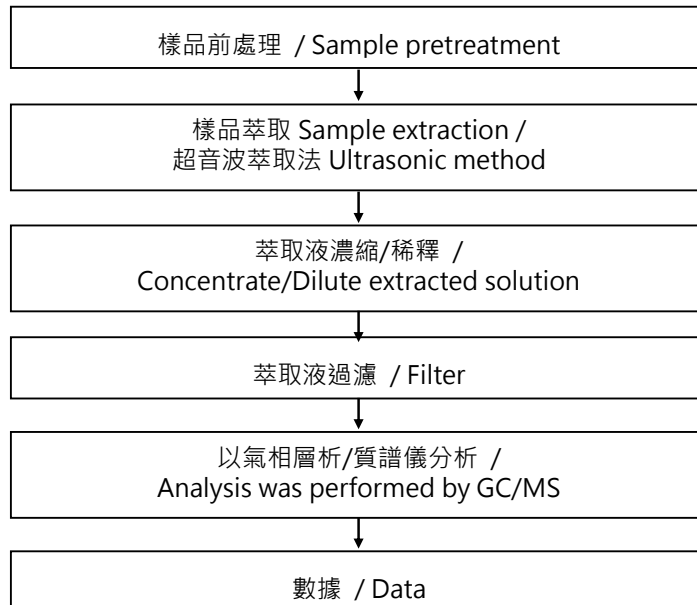

六溴環十二烷分析流程圖 / Analytical flow chart - HBCDD

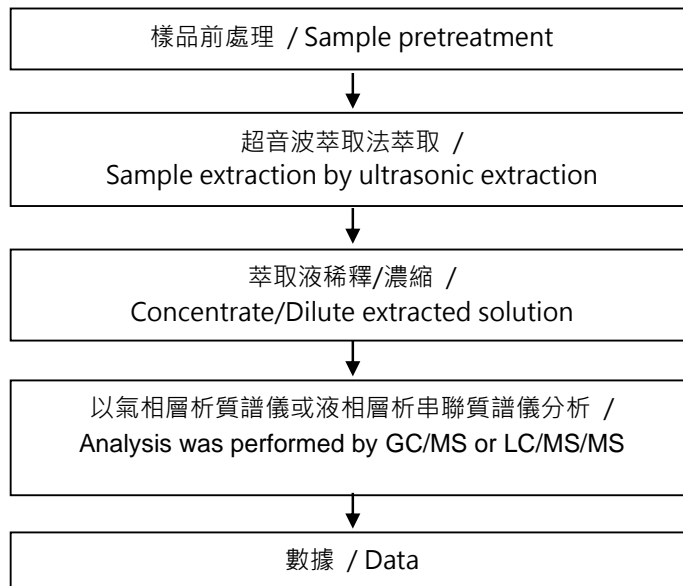

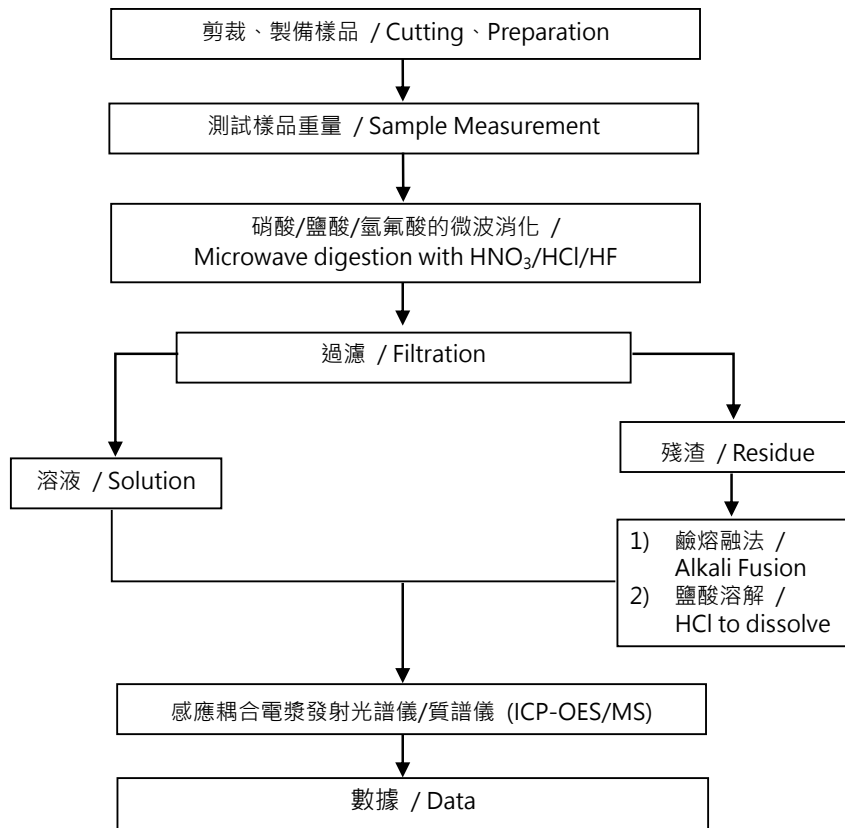

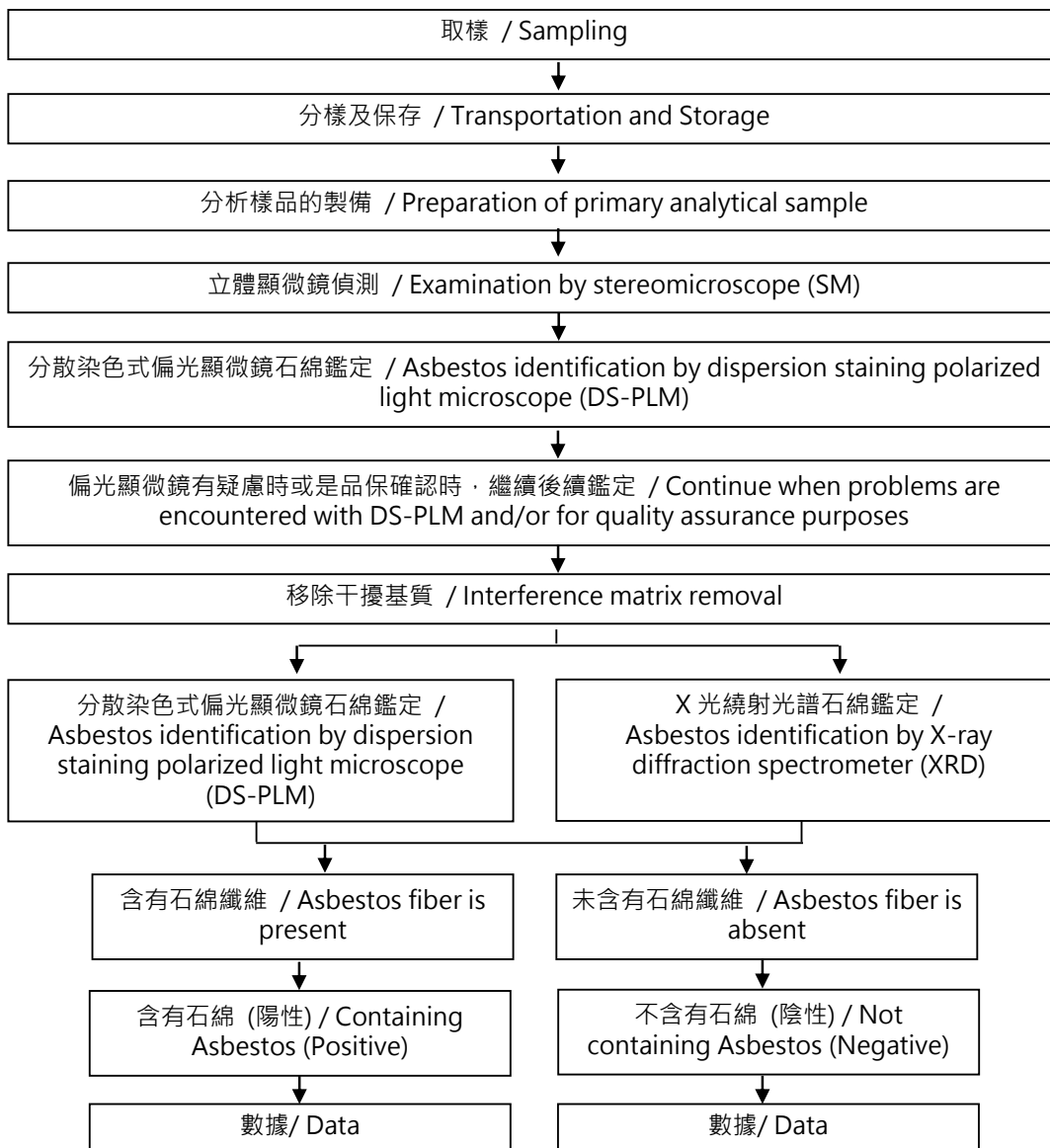
