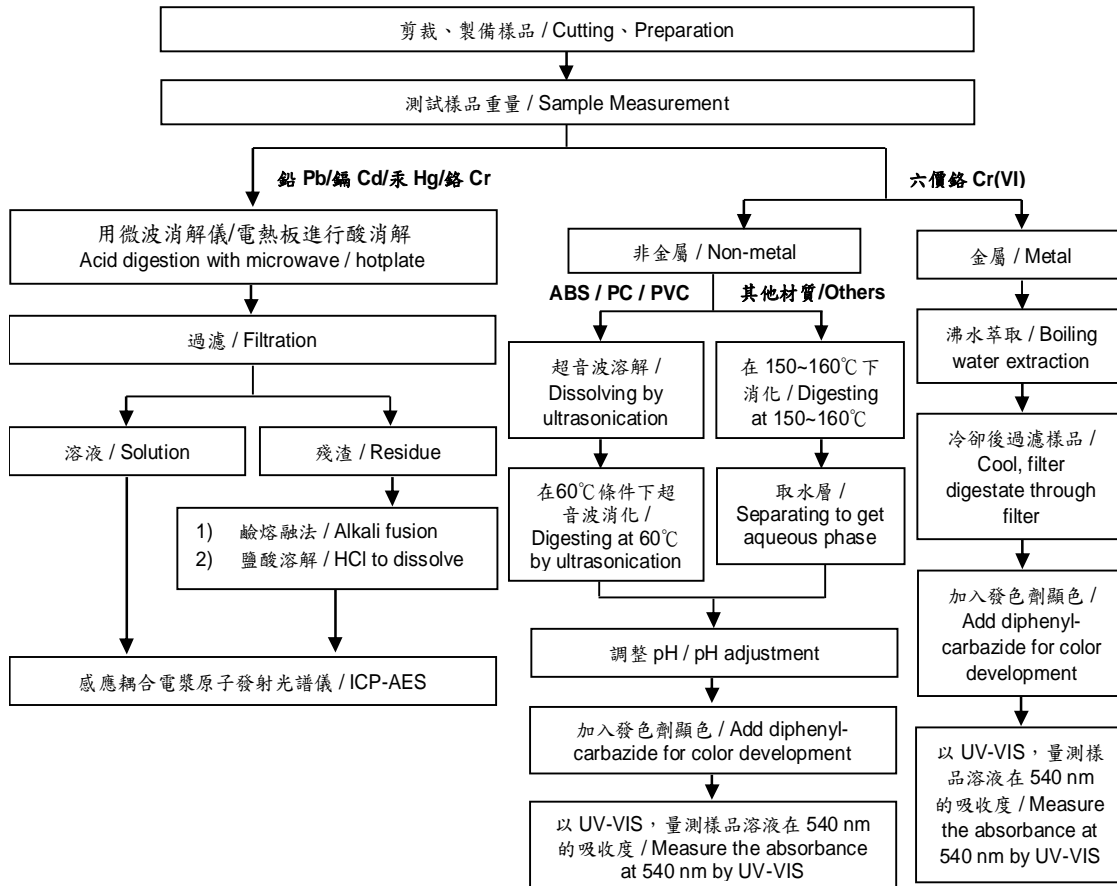


重金屬流程圖 / Analytical flow chart of Heavy Metal

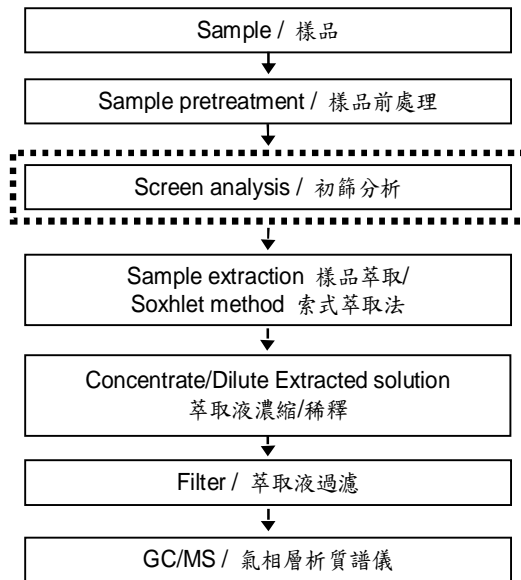

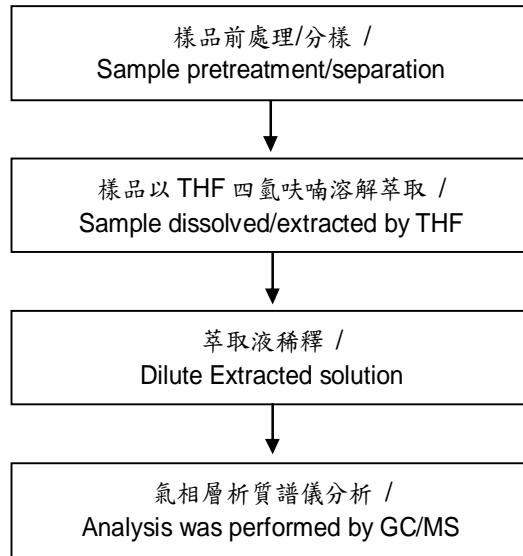

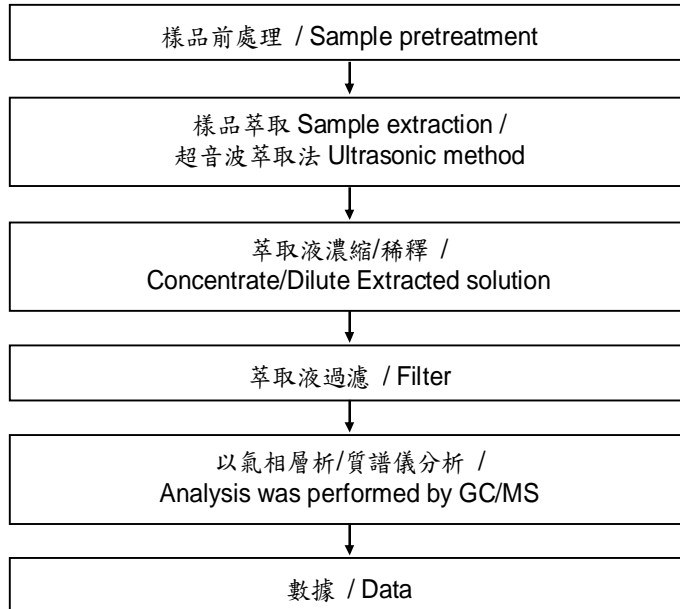

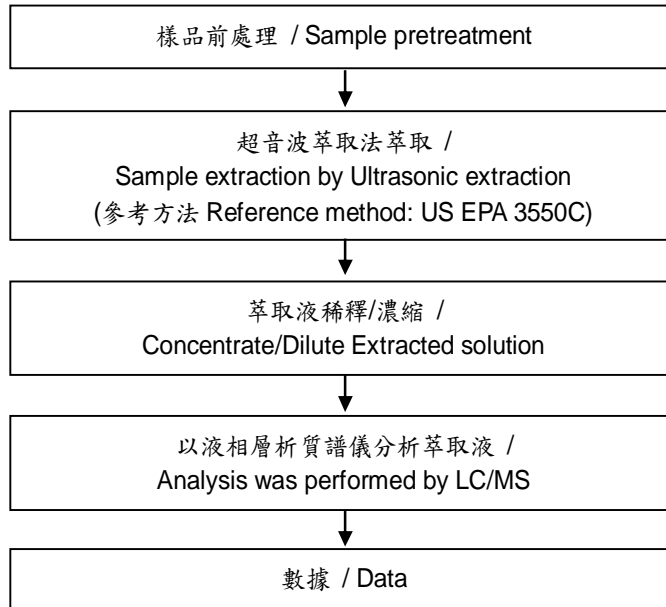
